# Waynesburg, Pennsylvania Registration Information and Course Selections <u>Summer 2019</u>

Summer sessions are designed to meet the needs of (1) high school students who desire early admission to college; (2) college students who wish to reduce the time necessary to complete the requirements for a degree or wish to make up deficiencies; and (3) others who seek self-improvement and greater competency.

The formal entrance requirements regulating the admission of students to the University are in effect for the summer session. A student in attendance at another college who desires to enroll for courses in the summer session at Waynesburg University is required to present a statement of good standing and a permit from the other institution. Students who are transferring from some other institution are advised to have their credits evaluated by the Registrar before registering for a summer session.

**New/Transient Students:** No formal application is necessary to take summer courses at Waynesburg University. However, students not previously enrolled are asked to complete an <u>Application for Non-Degree Student Admission</u>.

Students in good standing at another college or university may enroll with permission of the other institution. Summer school attendance does not constitute formal acceptance to Waynesburg University.

**<u>High School Students</u>**: Any 2019 high school graduate or high school student who has completed the junior year may be eligible to enroll in summer courses. Interested students are encouraged to contact the Office of the Registrar for more detailed information.

**Maximum Enrollment:** A student may enroll in a maximum of two courses per five-week session. Permission to enroll in more than 12 credits for the entire summer must be obtained from Academic Affairs.

**<u>Registration</u>**: A copy of the registration form can be found on page 5. Students have two options to register for summer courses.

- 1) Phone-in registration will be accepted for most courses. Call 724.852.3252 weekdays during regular business hours. If you register by phone, you may pay by credit card.
- 2) Walk-in registrations can be completed during regular business hours.

<u>Cost</u>: There is a one-time matriculation fee of \$20 for students not previously enrolled at Waynesburg University. Tuition is \$660 per undergraduate semester hour, and the fee to audit a course is \$270 per semester hour. All fees must be paid in full prior to the beginning of class.

**Financial Aid:** Students who wish to apply for financial aid for summer sessions must contact the Financial Aid Office at 724.852.3208 for additional information.

**Housing:** Housing for men and women is available in residence halls on campus. Arrangements may be made with the Student Services Office. Room charges, per five-week session, are \$1,130. Board arrangements will vary throughout the summer sessions. For more information on housing, contact the Student Services Office at 724.852.3206. To obtain board schedules, contact the University Dining Hall at 724.852.3264.

#### **TRANSCRIPTS**

Transcripts are provided by the Office of the Registrar and are issued only upon the written request of the student. No transcripts will be issued if the student has an outstanding debt at the University. All grades, continuous actions, degrees received, and degree honors are included on the transcript.

An official transcript carries the University Seal and an authorized signature. Official transcripts are usually mailed directly to educational institutions, employers, etc. However, a student may obtain an official transcript for his/her personal use. Each transcript must include the student's complete record at Waynesburg University.

#### **RELEASE OF INFORMATION**

This is to inform students that Waynesburg University intends to comply fully with the Family Educational Rights and Privacy Act of 1974, as amended, which was designed to protect the privacy of educational records; to establish the right of students to inspect and review their educational records, and to provide guidelines for the correction of inaccurate or misleading information and complaints with the Family Educational Rights and Privacy Act Office (FERPA) concerning alleged failures by the institution to comply with the act.

Waynesburg University designates the following information as public or directory information. Such information may be disclosed by the institution at its discretion.

Student's name; address; telephone listing; electronic mail address; photograph; date and place of birth; major field of study, grade level; enrollment status (e.g., undergraduate or graduate, full-time or part-time); dates of attendance; participation in officially recognized activities and sports; weight and height of members of athletic teams; degrees, honors and awards received; the most recent educational agency or institution attended by the student.

Currently enrolled students may withhold disclosure of directory information under the Family Educational Rights and Privacy Act II of 1974. To withhold disclosure, written notification must be received in the Office of the Registrar.

# **REFUND OF TUITION**

The total tuition is considered fully earned by the University on the first day of scheduled classes in any session. Students desiring to withdraw from the University must formally notify the University of their intention by processing a withdrawal form which can be obtained from the Office of Records and Registration (109 Miller Hall).

If the University has been formally notified of the student's intention to withdraw, and provided the student's tuition is in order, a tuition refund will be authorized as follows:

#### **Full Tuition Refund**

Notification to the University prior to the first day of classes and during the first three days of an applicable five-week session:

- A. A full refund of tuition for students completely withdrawing from the University.
- B. A full refund of the difference between tuition paid and the new tuition charge for students who drop courses but do not entirely withdraw from the University.

#### **One-Half Tuition Refund**

Notification to the University during the fourth and fifth day of an applicable five-week session:

- A. A refund of one-half of the tuition paid for students who completely withdraw from the University.
- B. A refund of one-half of the difference between the tuition paid and the new tuition charges for students who drop courses but do not completely withdraw from the University.

#### No Refund of Tuition

No tuition refunds are made beyond the periods specified below. Students with Federal Aid for summer classes should contact the Financial Aid Office at 724.852.3208 to determine the amount that will be refunded.
